This 20-hours class aims at introducing students to the main questions raised in the area of foreign and security policy by our contemporary multipolar world. The class focusses on understanding the major debates and challenges on international security issues and the players involved. It is based on a multi-faceted approach combining international relations, political science and international public law. The lectures will mix theoretical aspects and case studies on foreign policy and security issues in the 21st century. The class will be organised in 10 lessons of 2 hours each.

Each sequence is articulated around a main topic and will be developed as follows:

- International press quiz (warm up exercise)
- Introduction of the topic by the professor
- Students activities (debates, readings, presentations...)
- Complementary elements

For each lesson, at least one article or reading will be compulsory. Two students will have to present the article(s) to the class by explaining the article and debating the ideas. The presentations of the readings will be distributed during the first sequence, so that every student has enough time to prepare his oral presentation. The pair of student in charge of presenting the article(s) will prepare a Power Point presentation.

The final grade will be based on the following :

- Oral presentation of a scientific article	40 %
- Written exam (end term)	50%
- Oral participation and punctuality	10%
